Upon the foregoing papers this Motion and cross-motion to change venue granted. Although the summons alleges that venue is based on "defendants' principal place of business," the March 2016 affidavit by plaintiff's attorney concedes that venue is based on the principal place of business of defendant, Harold L. Goldstein, DPM, which he believes to be Bronx County. However, the affidavit by Dr. Goldstein sufficiently describes why his principal place of business is at WestMed Medical Group in Westchester County. (DiCicco v Catani, 5 AD3d 318 [1st Dept 2004].) In opposition, the evidence submitted by plaintiff merely demonstrates that Dr. Goldstein is affiliated with St. Barnabas Hospital in the Bronx. (Id.) Based on the aforementioned, the motion by Dr. Goldstein, and cross-motion by defendant, Vinai Prakash, DPM, are granted and this action is transferred to the Supreme Court in Westchester County. Upon payment of the appropriate fees, the Bronx County Clerk shall transfer this action to the Westchester County Clerk.
